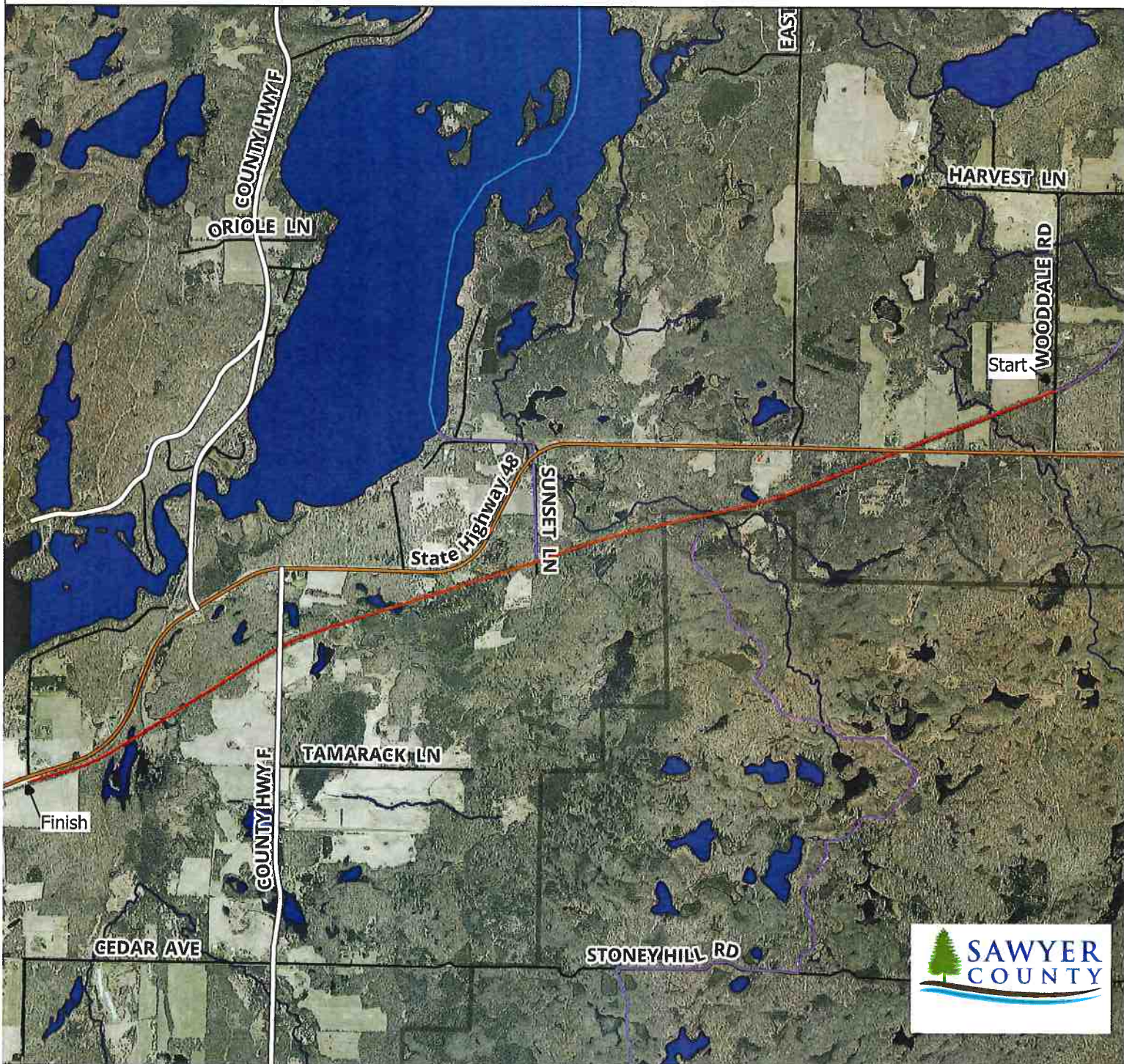

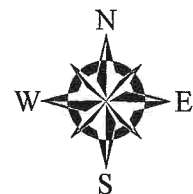
Tussockia Trail Rehab Wooddale Road to Washburn Co Line Sawyer County, WI T37N R9W

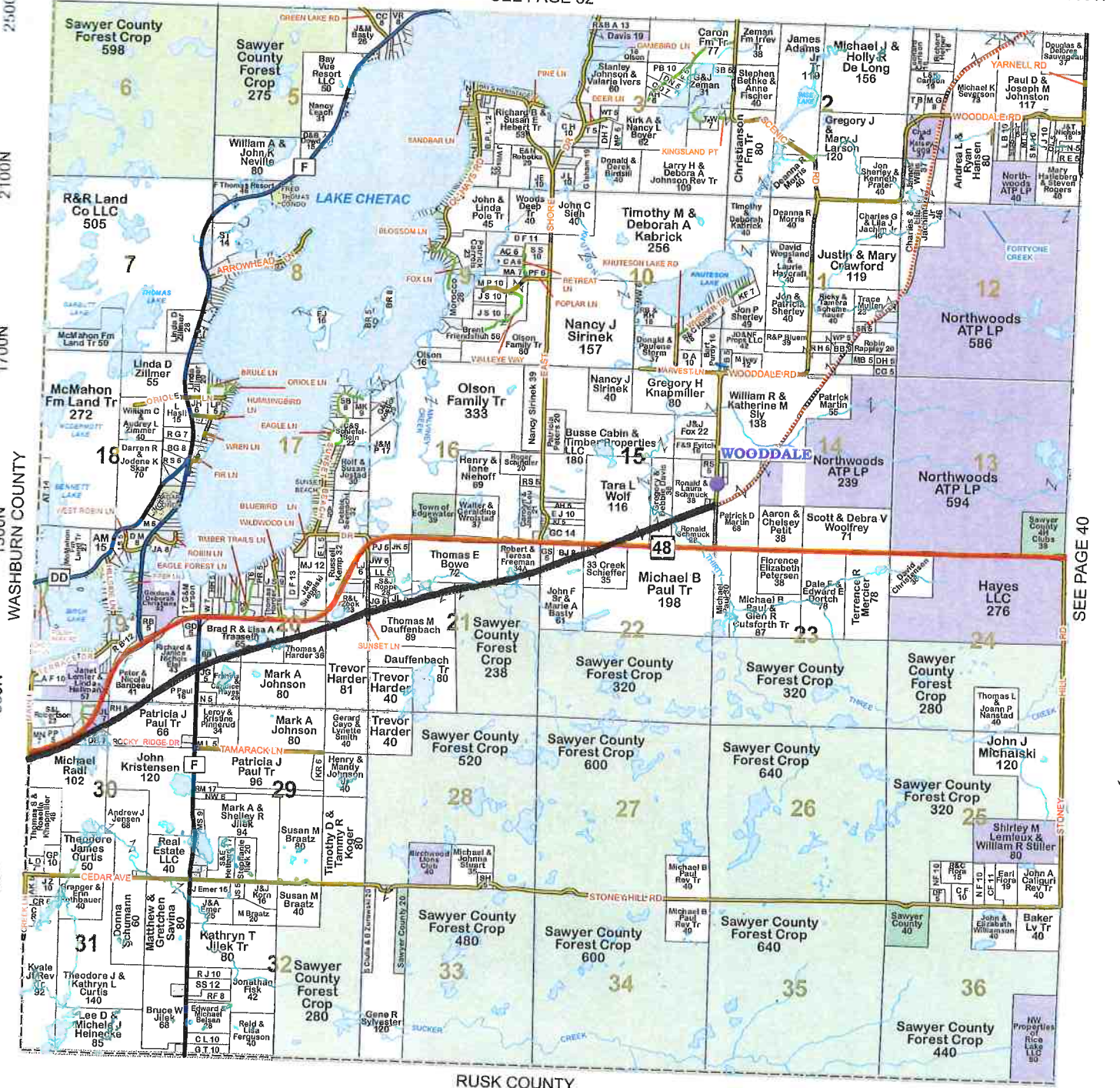
