Project Description Summary
Florence County would like to rehab a section of F2 trail NW of Pine River Rd. (45.8456001,-882564151)in the town of Commonwealth. This dual use, year round trail starts on Goodman Forest and ends on County owned property (45.8579902,-88.2627649) to the north. This project will involve the use of 1440 yards of 6" gravel and 470 yards of 6" crushed ore. There are a 2 low spots that are 18" deep and hold water for the majority of the season and into winter freeze up. There are also several low spots that should be raised to eliminate water traps. Adding run-outs and ditching will be beneficial to the trail also. There is an existing 12" ABS pipe that serves an intermittent stream for runoff during large rain events and spring thaw that needs to be replaced due to its size. We will place 20 yards of rip-rap on both the inlet and outlet sides to slow water flow and to combat current and additional trenching or scouring. We will also brush back the trail for increased visibility and to help eliminate riders from experiencing near collisions. We are asking for 80% (\$27,697.79) funding from the ATV-UTV Program and the remaining 20% (\$6,924.45) from the Snowmobile Program as this does provide a benefit to this dual use trail.

ATV 80%=\$28,338.00; Snow 20% = \$7,085.00

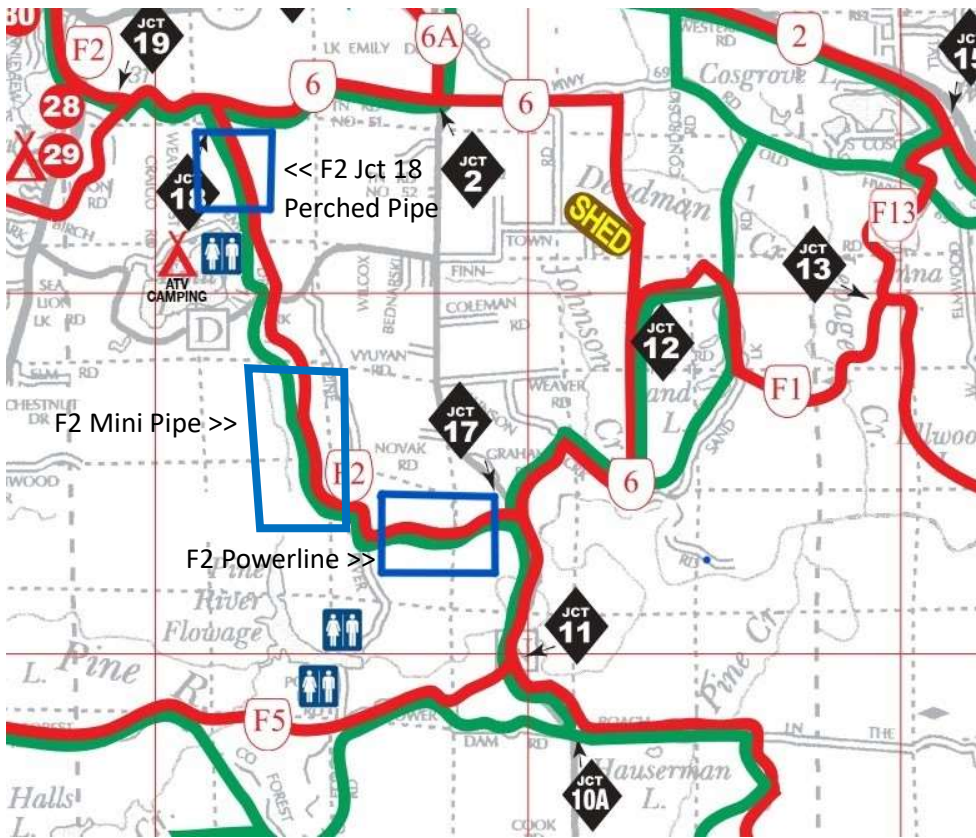
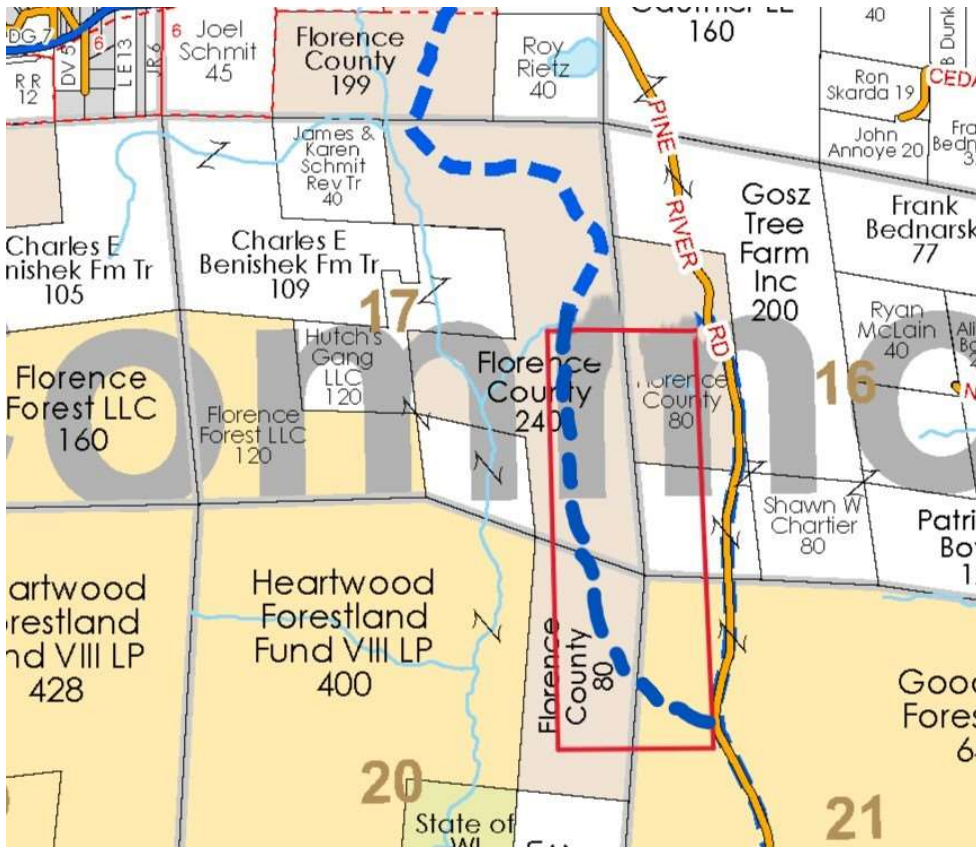

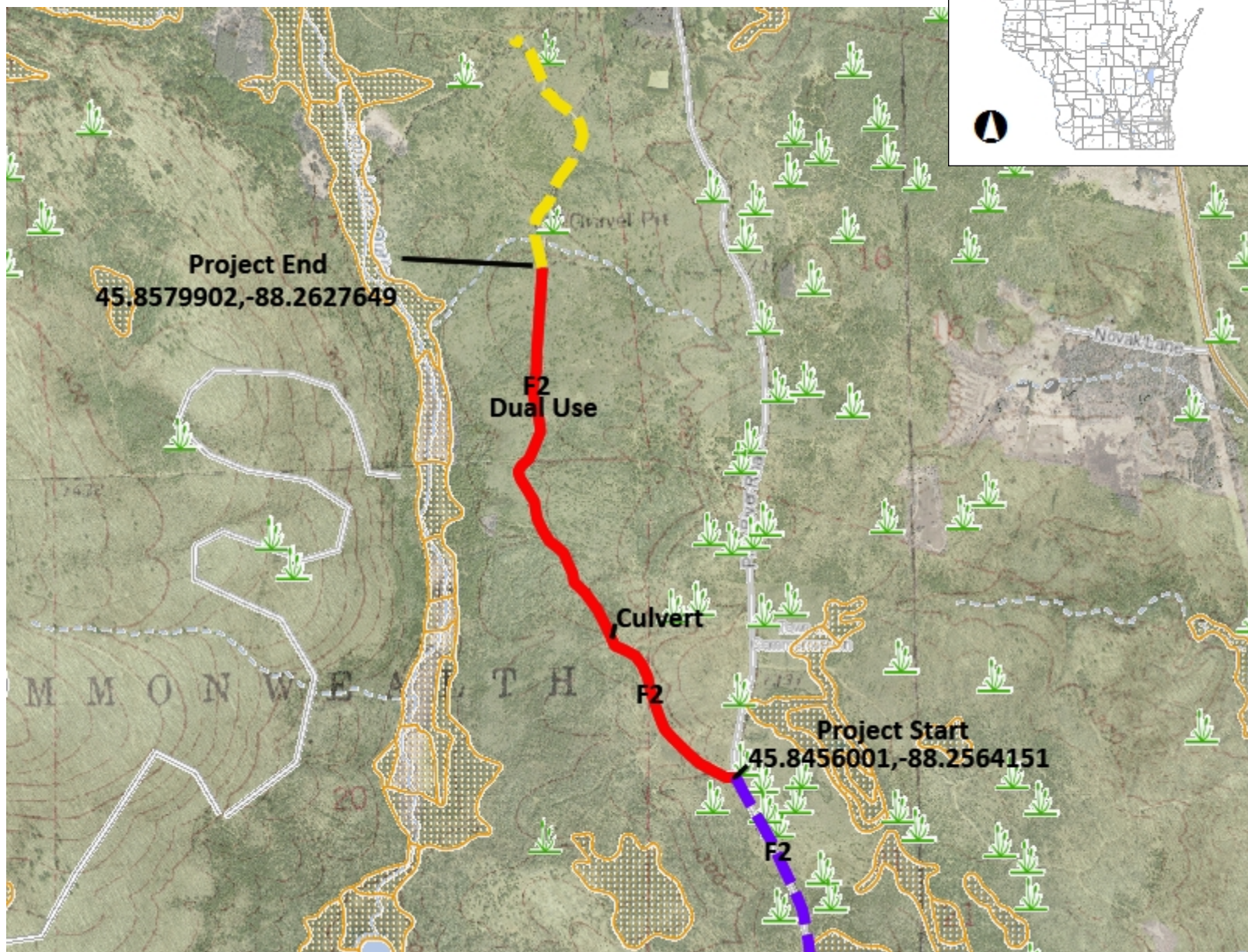
