Project Description Summary

Lincoln County is seeking maintenance funding for an additional 3.8 miles of winter ATV trail. The trail segment being applied for is currently a non-funded club trail that connects to the funded trail system directly and through other club trails. The segment begins at Corridor 16 in the Lincoln County Forest and heads north. It then travels down a short segment of town road route (which is not included in the mileage request). From there it heads west along Cty Hwy D and Old D until it reaches a parking lot, with room for 10 rigs, along the shore of Lake Alice. When the trail reaches Lake Alice it connects to a non-funded club trail which in turn connects to 2 other segments of funded winter ATV trail. The D Trail is a highly used segment that provides the high population center around Lake Alice access to the funded winter ATV trail system. Since the D Trail is currently a club trail there will be no development costs associated with this project. This trail segment is open to snowmobile use. Lincoln County winter ATV trails are not opened until one week after the corresponding snowmobile trail has been opened and trails are closed to ATVs when the temp is above 28 degrees F. UTV's are not allowed on winter ATV trails in Lincoln County.
