Bridge Project Detailed Description

Maximum load of current crossing structure (semi trailer bed) is unknown.

Upon award of a Motorized Recreational Grant, the landowner, Jeff Engelmann, is willing to enter into a 10 year minimum deeded easement with the County to cross his property for all portions of the snowmobile trail, including the crossing location, from Betts Road to Pike River Road. Jeff acknowledges the bridge installed with an awarded Motorized Recreational Grant would be owned by the County, see attached supporting document.

Upon a deeded easement being recorded, the crossing would be referred to the local DNR Water Management Specialist to initiate the permitting process as Holmes Creek would require permitting for the installation of the proposed bridge. The removal of the existing bridge will most likely be the obligation of the landowner with purchase and installation of the new bridge, covered under this application, to be completed by the awarded contractor.

The Marinette County Zoning Dept. was contacted regarding a floodplain determiniation of the location of crossing. The current elevation of the crossing will need to be raised, 1-2 ft in elevation, to be adequately above the floodplain. This is anticipated to be accomplished with an increase in fill material for the approach/base of the bridge on either side of Holmes Creek. However, the volume of material anticipated to be needed to raise the crossing structure above flood plain levels is not expected to be great enough to require a H & H (hydrologic and hydraulic) study.


