## LAND USE AGREEMENT

#### TO WHOM IT MAY CONCERN:

This is to certify that Trempealeau County through its duly authorized representative, and operational department, and hereinafter named the Permittee, is hereby authorized and permitted by Marian Severson hereinafter named the Owner, to enter upon and use the following described 1100 RODS 50 1 Acre land Section 10 , T 24 W, City, Village, or Township of N.R 07 , for the purpose of locating, OSSED constructing, and maintaining public snowmobile trail approximately 10 feet wide, on a one-rod wide right-of-way, including the installation of directional and informational signs, culverts, and/or bridges necessary to accomplish the intended use.

This permit shall be in effect on a continuous basis, but public use thereof shall be restricted to the period between December 1st of any year and April 1st the following year. This permit may be terminated, for just cause, by either party upon thirty (30) days written notice between April 1st and October 1st of the same year, but not until after one public use period of the intended use is completed.

It is understood by the Owner and the Permitee that this is subject to the following conditions:

- 1. The permit is non-transferable.
- 2. This permit shall be effective upon signing by both parties. Before locating the trail or making improvements or changes on the property, the Owner shall be notified of the plans and be given an opportunity to comment on the plan. Improvements will be done in such a way as to minimize erosion and any impact on the Owners use of the land.
- 3. The Permittee shall maintain the right-of-way, under permit, in a safe condition during the period of public use heretofore stated and shall be permitted and authorized to place signs along the trail in accordance with state funded trail standards.

- 4. The Permittee agrees to protect, indemnify, and save harmless the Owner, its agents and employees, from and against any and all Claims, demands, suits, liability and expense, by reason of loss or damage to any property or bodily injury to any person whatsoever, that may arise from the construction and placement of objects on the described lands and from the maintenance or use of the described lands.
- 5. Additional conditions specifically pertinent to this agreed land use will be valid if enumerated in the space provided between this condition and the closing signatures. Every such additional condition will be initialed by the Permittee and the Owner.
- 6. All slash and brush will be disposed of at the direction of the Owner.

Bridge Age: Unknown

## Bridge Condition (see photos – 2 pages):

- Deck: The timber decking is 31 3" by mostly 12" boards clipped to the top flange of the steel girders. The decking is very worn with some uneven longitudinal movement of boards creating 1"+ gaps between some planks. All plank are significantly worn in the center from snowmobile track studs. Currently, one plank is broken, two have been temporarily repaired with treated 2x4s. underneath and most are significantly weakened from loss of thickness. Worst damage is on the south end of bridge. The bridge railings attached to the ends of longer deck plank are very loose with some repaired damage.
- Superstructure: The steel I beams are significantly rusted with pack rusting on the top and bottom flanges and pit rusting throughout. There is no protective coating on the beams. Two steel diaphragms hold the I beams together and one diaphragm has holes completely through it.
- Substructure: The main substructure is four timber piling (one at each end of the I beams) with "L" notches cut in the top for the I beams to rest on. The pilings are in good shape. Since the abutments are simply the pilings supporting the I beams, there isn't a solid transition from the gravel trail to the bridge deck. The trail gravel erodes

down under the deck planks at each end of the bridge and eventually into the river during floods. A single wood plank retaining wall is located between the timber piling and the river but they aren't retaining much fill or rock located underneath the ends of the deck. One of the retaining planks is almost broke in two. There isn't enough large riprap under the bridge to protect the trail and bank during floods.

Channel: The channel makes a gentle bend through the bridge. The banks are steep underneath and around the bridge, but mostly well vegetated. Two dead trees are laying in the creek immediately upstream of the bridge and will cause issues with bridge integrity during floods if left in place.

# Bridge Maintenance Items & Recommendations:

Recommended maintenance is complete bridge rehabilitation consisting of removing the existing deck, installing a solid abutment around the timber pilings, riprapping the river bank underneath the bridge, cleaning and painting the steel I beams, and installing a new deck and railings. **Depending on rehabilitation costs, complete bridge replacement may be more economical and/or provide a lower long term annual cost.**


