**Project Description Summary**

Florence County would like to perform a rehab on Corridor C2 which connects Wisconsin to Michigan. The State of Michigan lies to the east and west of Florence County and C2 serves as the primary connection between the two states. It also provides the only connection to the western half of Florence County for ATV/UTV riders. This 13.7 mile long project will need an estimated 18,760 yards of gravel placed 6" thick then graded and compacted to 4". The original iron ore bed is still intact so no improvements are necessary. Since the pandemic, the dramatic increase in new ATV/UTV riders added to already staggering numbers of existing trail riders, Corridor 2 has been wearing away rapidly. The original 4" gravel cap has worn off leaving behind fine sands and silty dust making visibility a safety issue. We also experience dust out conditions along approximately 3.7 miles of the US2 Highway Corridor in areas with little to no vegetation barrier. This project will take an estimated 1095 hours of hauling and 6 weeks to complete barring any unforeseen circumstances. We have applied for RTP (\$250,000.00) and are asking for the remaining 80% to be covered by ATV/UTV (\$84,658.65) and remaining 20% (\$21,164.66) from the Snowmobile program.

The State of Michigan lies to the east and west of Florence County and C2 serves as the primary connection between the two states. It also provides the only connection to the western half of Florence County for ATV/UTV riders. This 13.7 mile long project will need an estimated 18,760 yards of gravel placed 6" thick then graded and compacted to 4". The original iron ore bed is still intact so no improvements are necessary. Since the pandemic, the dramatic increase in new ATV/UTV riders added to already staggering numbers of existing trail riders, Corridor 2 has been wearing away rapidly. The original 4" gravel cap has worn off leaving behind fine sands and silty dust making visibility a safety issue. We also experience dust out conditions along approximately 3.7 miles of the US2 Highway Corridor in areas with little to no vegetation barrier. There have been complaints over the years regarding the amount of dust created most notably during the weekend which typically starts on Thursday and ends on Sunday. Those living trailside are the ones most affected by this and complaints range from dust covered vehicles, houses, and even their yards. This project will take an estimated 1095 hours of hauling and 6 weeks to complete barring any unforeseen circumstances. We have applied for RTP (\$250,000.00) and are asking for the remaining 80% to be covered by ATV/UTV (\$84,658.65) and remaining 20% (\$21,164.66) from the Snowmobile program.

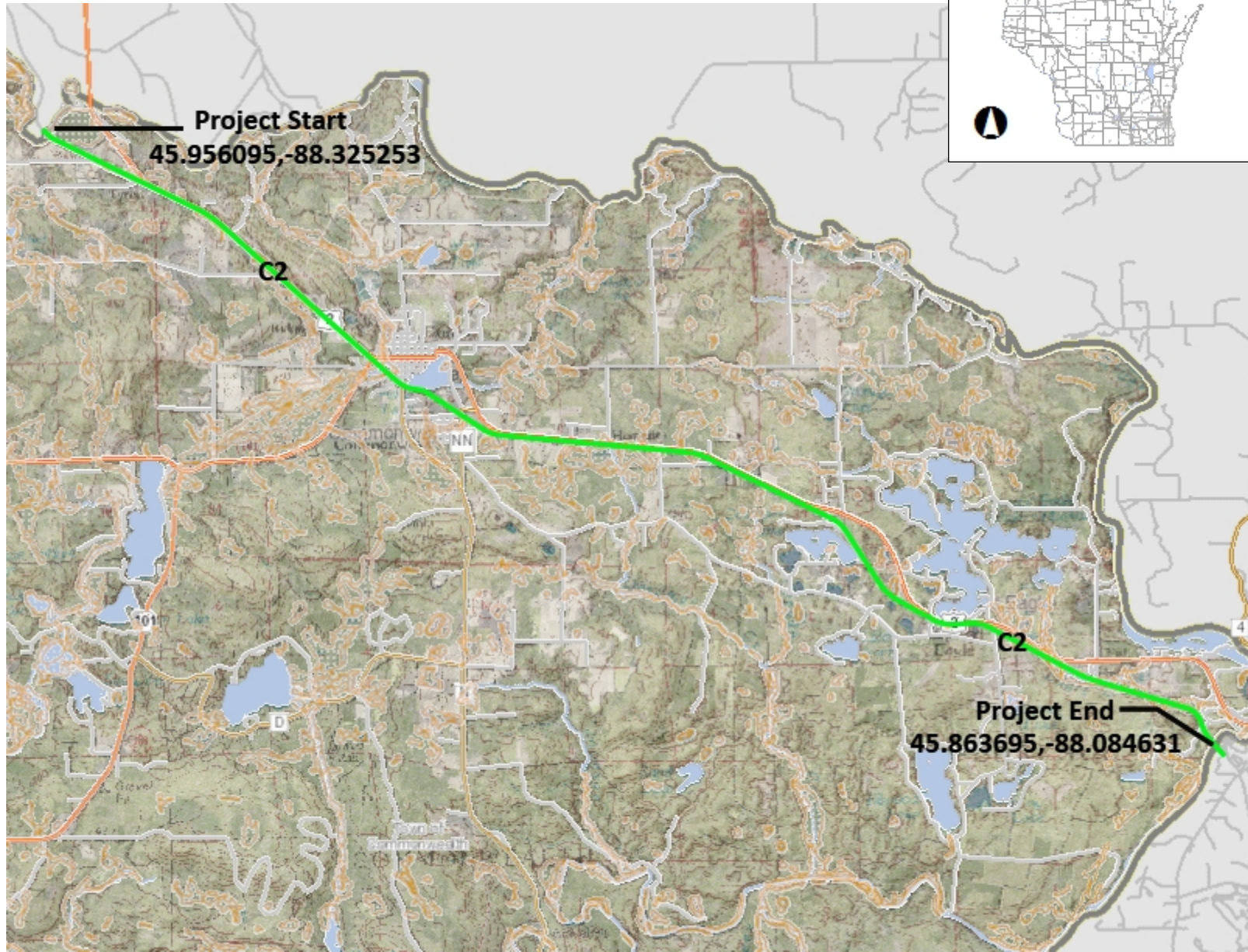
