

Then at Rock Creek road and Suszka Lane- Goodman Grade heading south for .65 miles to Forest County line. Total mileage is 3.55 miles. Trail starts at JCT.6, F8 at coordinate 45.731755,-88.461503 heads south to end coordinate at Memory Lane and County C 45.744271,-88.425399. Trail F8 starts again at Suszka Lane- Goodman Grade at 45.731779,-88.461502 and ends at 45.722793,-88.462246 and Forest County line for .65 miles.

6. Approved, fully reflectorized snowmobile signs must be used.
7. **Night travel on or in the vicinity of highways must be in the direction of vehicular traffic in the nearest lane unless:**
 - **The snowmobile trail is located at least 40 feet from the roadway, or**
 - **is separated from the roadway by a head lamp barrier.**
8. Snowmobile trails shall not be routed over bodies of water. If stream crossings make bridging necessary, bridges should be at least 8 feet wide. If the bridge is located on an abandoned railroad grade, the bridge shall be a minimum of 10 feet wide free from obstruction.

- 1) Trail serves as a connector trail to Corridor 8 in Forest County.
- 2) This trail leads into the Town of Fence and provides trail users with a gas station, convenience store, and bar/grill. Trail F8 continues into Forest County and connects with Corridor 8 and the Town of Armstrong Creek.
- 3) This trail sees a high volume of traffic due to the availability of gas. This location is the only establishment centrally located in the southern part of Florence County.

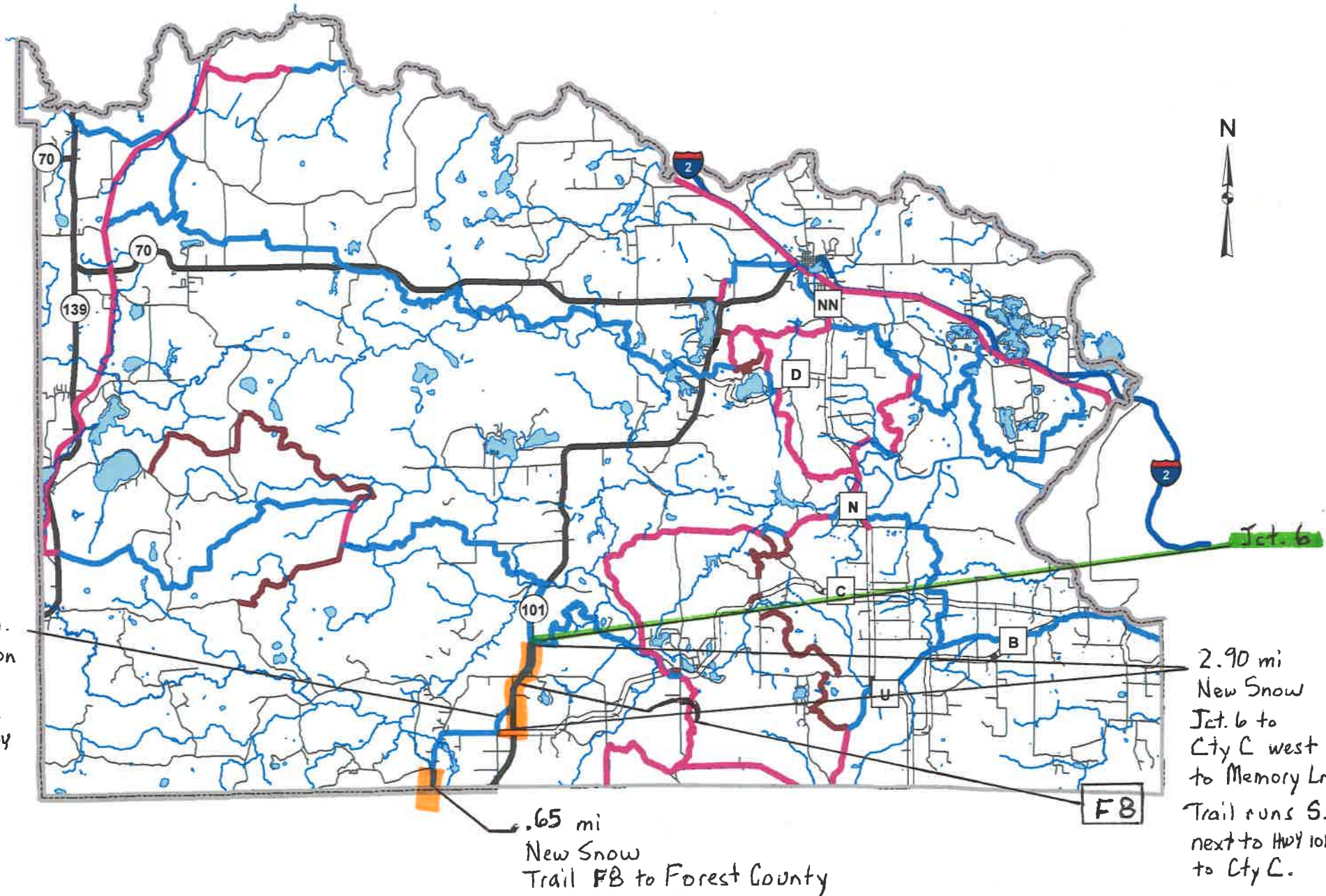

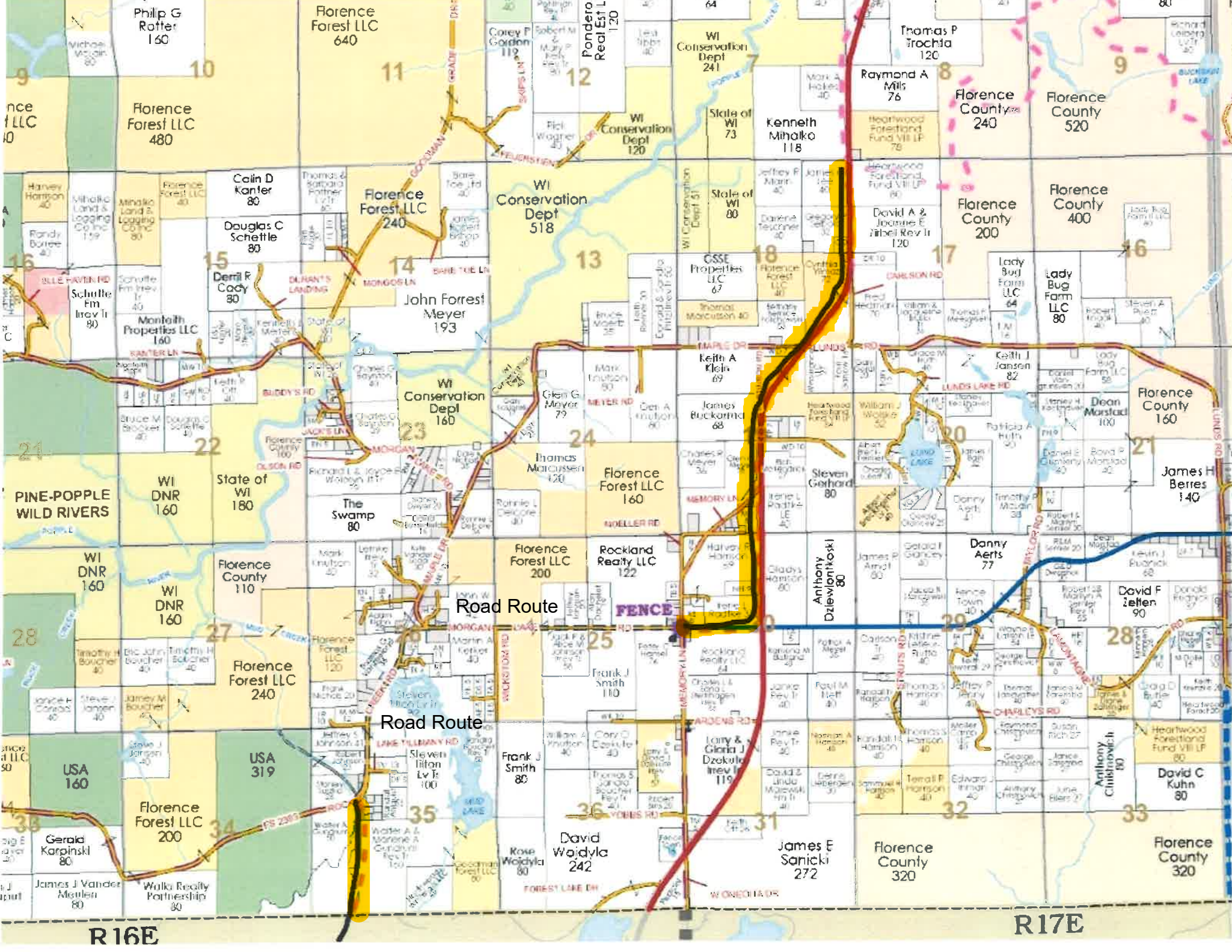
Combination Snowmobile, ATV and UTV Trails

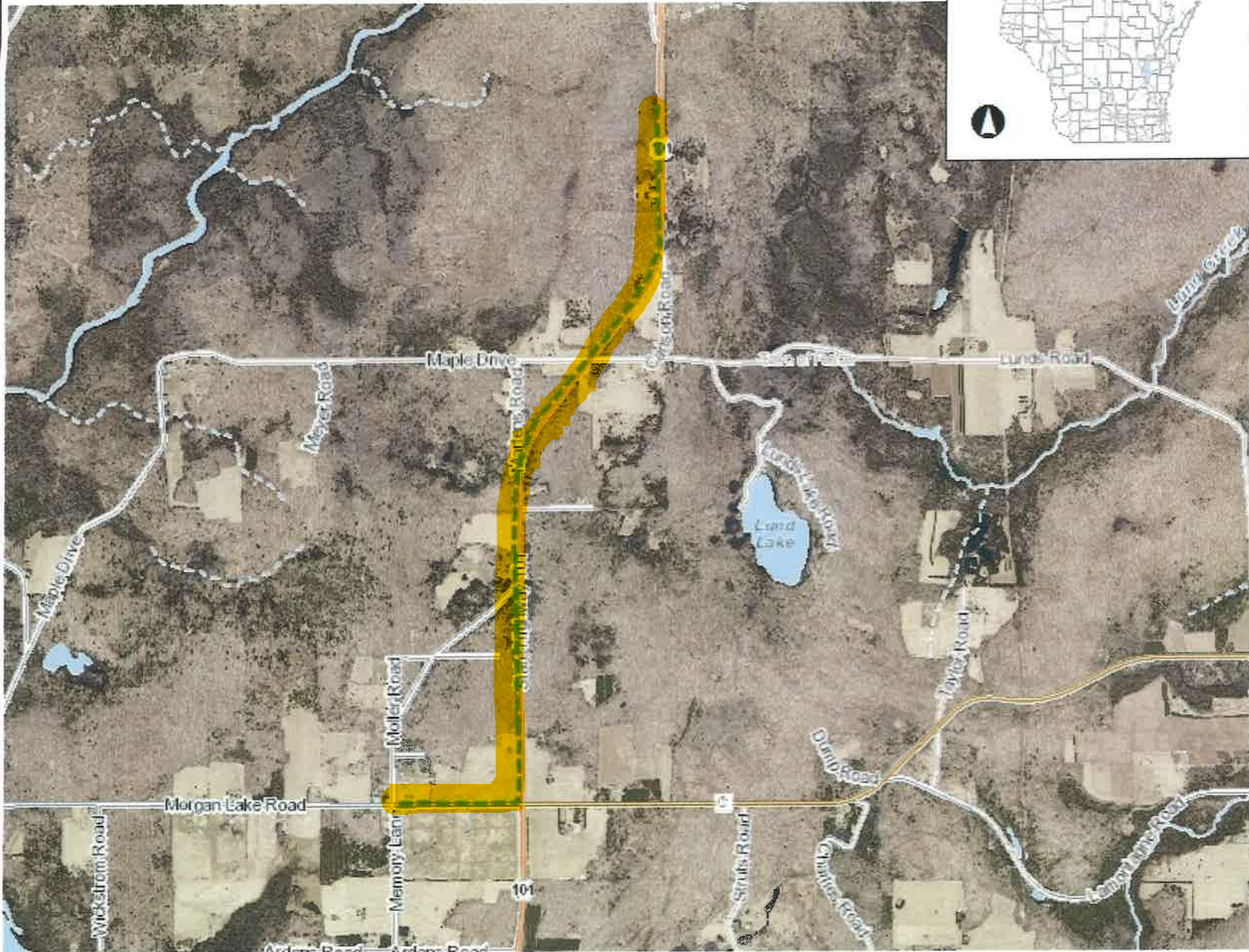

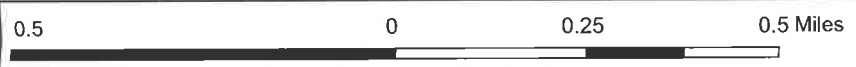
