





Financial Assurance

Recommended factors in determining financial responsibility costs include:

- Complexity of sites
 - Simple sites (generally less than 2 acres, low degree of engineering, commonly used materials) may start with a baseline of \$100,000 that may be increased or decreased depending on site conditions
 - Complex sites may consider figures, which as a minimum constitute 5% of construction costs, including procurement, design, permitting, mobilization, repair; generally resulting in a minimum of \$100,000
- Proof period duration (similar to Superfund sediment sites); 30 years with 5-year review
- Robustness of cap and cap complexity
- Velocity of the waterway
- Chance of failure
- Level of risk
- Frequency of extreme weather events
