Review Takeaways from Last Meeting

• Meeting notes and materials from June 7, 2023 meeting

Vapor Intrusion Continuing Obligations Discussion (Jennifer Borski and Bill Nelson)

- Discussed the need to implement internal procedures and tracking mechanisms for vapor mitigation system (VMS) continuing obligations ahead of closure, and the need to promulgate code requirements relating to VMS continuing obligations ahead of closure.
- DNR Vapor Intrusion team is currently implementing a pilot project in the DNR northeast region to research and document best practices for implementing and tracking VMS. This will also enable RR staff to provide experience-based input for any future rule development.

DNR RR Program Process Brainstorming

- Open invitation to discuss any RR Program processes that are operating well or have room for improvement. Topics that arose during discussion include:
 - o frequent communication between responsible parties, consultants, and RR program project managers (PMs) to allow PMs to identify issues quickly and thus help projects avoid delays;


