## Great Lakes Fishing Guide Report

Form 9400-610 (R 12/21)

**Please remember that completion of this paper form is only required if the guided trip IS NOT entered and uploaded to the electronic guide reporting system within 24 hours due to connectivity issues or if the system is not in operation. The following instructions are designed to assist the licensee in preparing this report of guided fishing activities:**

**NAME:** Print your name as it appears on your guide license. List any additional names operating under same guiding business.

**DNR CUSTOMER NUMBER:** Enter the DNR Customer Numbers found on each guide's license. If multiple dates/trips are entered on a single form, please ensure ALL of the guides listed were in fact part of ALL of the listed dates/trips.

**MAJOR WATERBODY:** Check the box next to the major waterbody on which you are guiding.

**SUB-WATERBODY:** Check the box next to the sub-waterbody on which you are guiding.

**GRID:** If fishing in the main waters of Lake Michigan or Lake Superior, enter statistical grid.

**HARBOR:** Enter specific harbor, as applicable. (Grid number required for Lake Superior)

**TRIBUTARY:** Enter specific tributary, as applicable.

**DATE:** Enter the date (MM/DD/YY) on which the guided trip occurred. Record each fishing party as a separate entry (i.e. you guide two separate parties on the same date, enter the date twice with a separate line for each fishing party).

**NUMBER OF ANGLERS:** Enter the total number of anglers guided on this day (separate by party, if applicable).

**HOURS FISHED:** Enter the number of hours that each party was engaged in fishing, rounded to the nearest hour. Enter each party and their respective effort and catch on a separate line.

### **FISH DATA (Fill in the species name at the top of the shaded area, as applicable)**

**CAUGHT:** Enter the total number caught by anglers in the fishing party on the day (include released and kept fish).

**KEPT:** Enter the total number kept by the anglers in the fishing party on the day.

**TAG NUMBERS:** Enter any fish tag numbers from any fish caught.
