Rule Information: This rulemaking package will propose to comprehensively review and update current code requirements and procedures for the planning and design of sewerage (sewage/wastewater) systems. The primary goals will be to update code requirements to better reflect new technologies and broadly accepted engineering design standards, improve clarity and ease of use for owners and design engineers of sewerage systems, and identify potential staff workload reduction measures associated with program implementation. The proposed new or modified requirements will also aim to address any new or emerging issues as they arise. The rulemaking process will be informed by a technical advisory committee and the Great Lakes – Upper Mississippi River Board’s Recommended Standards for Wastewater Facilities (10 States Standards).
