

TRACT 1-22 – SUPPLEMENTAL REQUIREMENTS

The following terms and conditions supplement those provided in the Timber Sale Contract.

A. PRESCRIPTION:

1. Harvest Unit 1: Red pine thinning
2. Harvest Unit 2: Coppice with reserves

B. HARVEST REQUIREMENTS:

1. Harvest Unit 1: Cut all trees marked with orange paint. Sever all stems greater than 2" within red-lined pocket mortality area.
2. Harvest Unit 2: Leave uncut and undamaged all pine, oak, white spruce, and trees marked with purple paint. Leave uncut and undamaged all trees within purple-marked reserve islands. Sever all other stems 2" and greater. Minimize damage to unmerchantable balsam fir seedlings within harvest unit and unmerchantable trees along field edge.

C. OPERATIONAL REQUIREMENTS:

1. Sale is being sold on a ticket scale basis.
2. Unit 1 is bounded by open fields, a buried powerline ROW, and a cover type change.
3. Unit 2 is bounded by a red paint line and open fields.
4. Slash must be evenly scattered throughout the harvest area and kept under 3 feet in depth. Do not place slash across red line, in open fields, or on buried powerline ROW.
5. Utilization specification is to a 4" top.
6. No biomass harvesting is allowed.
7. Do not damage any survey monumentation.

D. SEASONAL RESTRICTIONS:

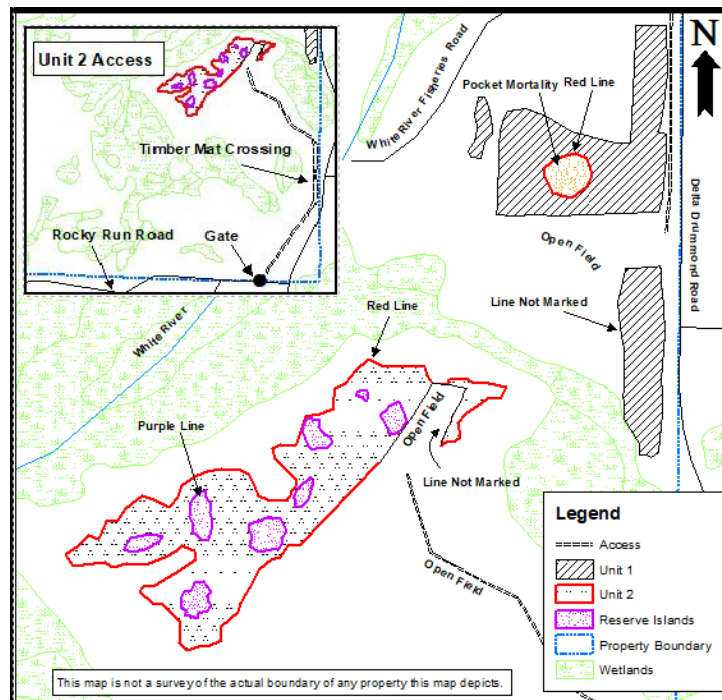
1. All harvest units will be accessed and harvested during leaf-off frozen ground conditions only.

E. ACCESS AND ROADS:

1. This contract requires DNR authorization for all road/landing construction and places several other requirements on road construction, maintenance, and closure. See timber sale administrator for access and road requirements.
2. Access for unit 1 is the buried powerline ROW off White River Fisheries Road.
3. Access for unit 2 is the gated woods road off Rocky Run Road.
4. Timber mats will be needed on a section of access road when accessing harvest unit 2. There may be mats available for use at the Barnes Ranger Station. Length of wet area requiring mats for crossing is 160 feet, beginning at coordinates 46.445336N, -91.271756W and heading north.
5. Water bars will need to be constructed upon completion of hauling activities on access road from unit 2. Contact timber sale administrator for details.
6. All soil displaced in the open fields during access construction/use will need to be replaced upon completion of hauling activities.
7. Signage will need to be placed on White River Fisheries Road and Rocky Run Road notifying users of harvest operations.

F. OTHER:

1. This sale will be sold as a three (3) year contract.
2. Prior to any work on access roads, call Diggers Hotline and allow sufficient time for utility delineation work.
3. To comply with best management practices for invasive species: prior to moving equipment onto or off the sale area, scrape or brush soil and debris from exterior surfaces to the extent practical.
